Emissions reduction targets

To continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

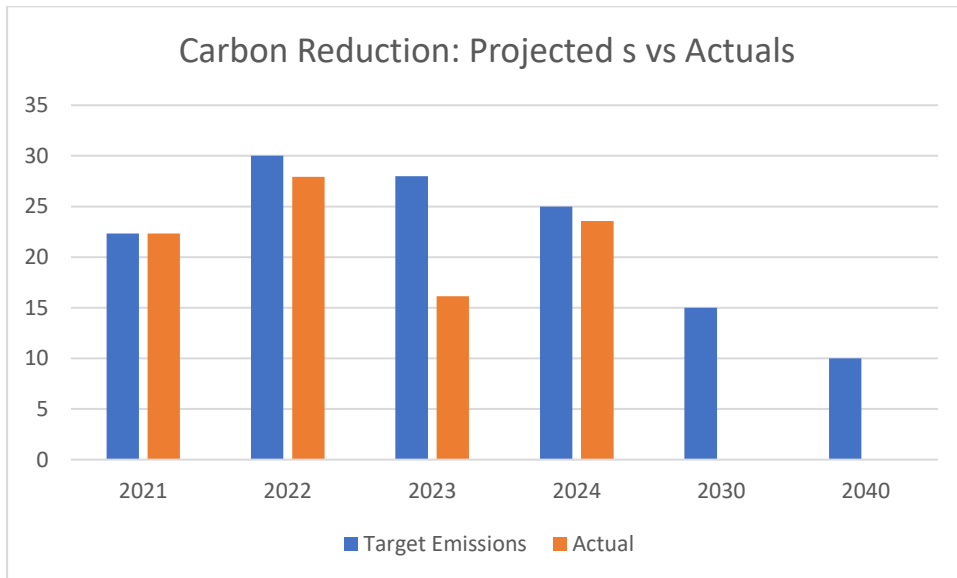
We project that carbon emissions will decrease over the next five years to 16.75 tCO₂e by 2027. This is a reduction of 25%.

Our Scope 3 Business Travel was not measured for the Baseline Year as the data did not exist in a reportable format. Our emissions have increased this year but are in line with our reduction targets, our business travel increased due to the creation of a new BD role which due to the nature of the position involves a considerable amount of travel, public transport choices have and are being utilised as opposed to vehicle travel where possible. A continued growth of the company has resulted in an increase to our Employee Commute data.

Our Scope 2 Electricity & Gas are out of scope as we are in a leased building with no control over the supply to the building, in future as we are able to measure these we will report accordingly. Again this may raise our current emissions.

Completed Carbon Reduction Initiatives

JD2E Ltd have joined the SME Climate Hub and have designed a strategy to start working towards our goals and will be reporting our progress and emissions annually to the UN Race to Zero to be accountable for implementing our plan and monitoring our progress.

JD2E Ltd allows employees the ability to work from home, where applicable and appropriate, to reduce Scope 3 emissions.

Use of technology for virtual meetings is always considered before business travel plans are made.

Goals:

- Halve our emissions by 2030
- Net zero by 2050

In the future we hope to implement further measures such as:

- Replacing business vehicles with electric models.
- In conjunction with other leasees, work with the owners of the leased buildings, to discuss and implement use of green suppliers of energy.
